In consideration of being permitted to participate in the sport of target shooting under the auspices of "The Colby Shooting Club", and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Undersigned hereby:

1. Acknowledges that the risk of injury from this activity, including the potential for permanent disability and death, though slight is significant, even with the use of protective equipment, supervision and compliance with range rules and notwithstanding, hereby **KNOWINGLY AND FREELY ACCEPTS ALL RISKS** arising from such activities, both foreseeable and unforeseeable, including without limitation, any risks occurring at the premises of The Colby Shooting Club or associated with instruction in the use of firearms, the discharge of firearms, the firing of live ammunition and any other activities conducted thereat.
2. Agrees at all times to abide by all range safety procedures, rules, regulations and directions of any range officer, and to report any unusual activity or hazard observed to the attention of the range officer.
3. Releases The Colby Shooting Club, its employees, directors, officers, agents and landlord from and hereby waives for himself/herself and his/her executors, administrators, dependants, assignees or heirs, any and all rights and claims for damages, losses, demands and any other actions whatsoever (including, but not limited to any and all injuries, damages or illnesses suffered by the Undersigned or the Undersigned's property), which he/she may have or which may in any way whatsoever, arise out of, be related to or be connected with activities conducted at The Colby Shooting Club or in the course of instruction at the Club's premises, any latent defect in the premises, the Undersigned's presence on or use of said premises.
4. Agrees to indemnify and hold harmless The Colby Shooting Club, and any of its employees, directors, officers, agents and landlord, from any and all liabilities, costs, expenses, claims, demands or lawsuits howsoever arising out of, related to or connected his/her presence at or use of the said premises, participation in activities associated with the Colby Shooting Club, including the discharge of firearms and participation in the course of instruction and for any and all acts or omissions of the Undersigned.

I have been given instructions in gun handling safety and range procedures and I am confident that they are adequate to provide for my safety.
